AUSSIE INFLATABLES HIRE AGREEMENT FORM

PLEASE READ THIS DOCUMENT CAREFULLY. WHEN HIRING AN INFLATABLE, YOU ARE ASSUMING RESPONSIBILITIES SPECIFIED BY LEGAL REGULATIONS. YOU MUST SATISFY YOURSELF THAT YOU UNDERSTAND, AND CAN COMPLY WITH THE AGREEMENT AND THE INSTRUCTIONS.

HIRE AGREEMENT

PERIOD OF HIRE: COMMENCES AT THE POINT AUSSIE INFLATABLE STAFF SET FOOT, DRIVE VEHICLE ONTO THE LOCATION/PROPERTY WHERE PRODUCT/S ARE TO BE SETUP. THE PERIOD OF HIRE CEASES THE MOMENT ALL PROPERTY PROVIDED/USED TO COMPLETE SETUP HAS BEEN REMOVED FROM THE SAID LOCATION/PROPERTY.

CONTROL OF THE INFLATABLE: COMMENCES ONCE OPERATING INSTRUCTIONS HAVE BEEN EXPLAINED TO CLIENT AND CEASES WHEN AUSSIE INFLATABLE STAFF RETURN AND ALL PARTICIPANTS HAVE BEEN SAFELY REMOVED FROM THE EQUIPMENT. PLEASE NOTE THAT IT IS THE CLIENT'S RESPONSIBILITY TO REMOVE ALL PARTICIPANTS FROM INFLATABLE PRIOR TO AUSSIE INFLATABLE STAFF RESUMING CONTROL OF INFLATABLE.

SUPERVISOR: THE HIRER SHALL PROVIDE A PERSON/S 18 YEARS OF AGE OR ABOVE. THAT PERSON/S MUST BE A RESPONSIBLE PERSON/S AND CAPABLE OF EXERCISING CONTROL OVER THE PARTICIPANTS THAT ARE USING THE EQUIPMENT PROVIDED AND MUST NOT BE UNDER THE INFLUENCE OF ANY DRUGS OR ALCOHOL. THE SUPERVISOR/S MUST ALWAYS HAVE A CLEAR AND UNOBSTRUCTED VIEW OF THE PARTICIPANTS AND MUST NEVER LEAVE THE INFLATABLE UNATTENDED. PLEASE NOTE THAT THE ADULT WHO HAS BEEN TRAINED BY AUSSIE INFLATABLES STAFF ON HOW TO SAFELY OPERATE THE PRODUCT/S MUST ALWAYS REMAIN WITH THE INFLATABLE/S WHILST THEY ARE BEING USED. ANY STAFF THAT MAYBE ASSISTING THE ADULT TRAINED BY AUSSIE INFLATABLES MUST BE SHOWN HOW TO OPERATE THE PRODUCT AND THE TRAINED STAFF MEMBER MUST ENSURE THEY ARE COMPETENT IN DOING SO BEFORE THEY BEGIN SUPERVISING PRODUCT/S.

OPERATING PROCEDURES: PLEASE REFER TO OUR SAFE OPERATION PROCEDURES PROVIDED

EMERGENCY SITUATIONS: PLEASE REFER TO OUR WEATHER MONITORING POLICY PROVIDED FOR DETAILED INFORMATION REGARDING WHAT TO DO AND HOW TO PREVENT ANY POTENTIAL INCIDENTS ARISING FROM ADVERSE WEATHER CONDITIONS AND SAFE EVACUATION IN CASE OF INJURY/EMERGENCY.

CLEANING FEE

A CLEANING FEE MAY APPLY IF THE INFLATABLE IS LEFT IN AN UNSATISFACTORY CONDITION. THE CHARGE IS A \$100 FEE AND IF IT REQUIRES MORE ATTENTION, IT IS THAN AN EXTRA \$40 FOR EACH HOUR THERE AFTER.

PROPERTY DAMAGE

TO PRODUCT HIRED: IF AN INFLATABLE IS FOUND TO BE DAMAGED IN ANY WAY, THEN THE HIRER WILL BE LIABLE FOR THE COSTS OF ANY EXPENSES ASSOCIATED WITH HAVING THE INFLATABLE REPAIRED TO THE CONDITION IT WAS ORIGINALLY IN ON THE DAY IT WAS HIRED OUT TO THE HIRER.

AT THE SETUP LOCATION: IF THE STAKES/PEGS THAT WE HAVE USED TO SECURE THE INFLATABLE AND/OR VEHICLES, TROLLEYS ETC THAT WE HAVE USED TO TRANSPORT THE PRODUCT TO THE LOCATION OF SETUP HAVE CAUSED ANY DAMAGE TO YOUR PROPERTY, WE ARE NOT RESPONSIBLE. IT IS THE HIRER'S RESPONSIBILITY TO CLEARLY MARK OUT THE LOCATION OF ANY RETICULATION, UNDERGROUND PIPING OR OTHER POTENTIAL ISSUES/HAZARDS AT THE LOCATION PRIOR TO SETUP AND TO PROVIDE GUIDANCE ON THE DAY OF SETUP.
